

### IPOPHL grants TSU its first patents

For the first time in the Tarlac State University's (TSU) history, the Intellectual Property Office of the Philippines (IPOPHL) granted patent registration to three faculty innovations-two from the College of Technology and one from the College of Engineering.

Specifically, the three innovations were registered as utility models under the ownership of TSU on June 15, 2016 and are protected under the law for seven years from the date of filing.

A utility model is an intellectual property right that is designed to protect an innovation that is of practical utility, novelty, and industrial applicability but lacks an inventive step to meet the requirements for standard patent application.

Faculty researchers Prof. Arnel A. Punla, Engr. Larry A. Suboc, Mr. John Nelson Y. Punla, and Ms. Eddie Lynne P. Sevilla from the College of Technology are the registered "makers" of the utility model entitled "An Apparatus for Cooking Raw Sugar such as Muscovado and the like," with registration number 2-2015000567.

The said utility model is a device used for cooking muscovado sugar that features a mechanized continuous stirring mechanism to ensure high quality of the output.

The same group of faculty researchers are behind the utility model entitled \* A Vibratory Rotary Sifter for Separating Materials." Granulated with registration 2-2015000332.

The rotary sifter was initially conceptualized for the vermi-compost industry to separate worms from compost efficiently, but may also be used for other applications.

The application of the two aforementioned utility models was initially facilitated by Dr. Murhpy P. Mohammed who was then the Director of the Production Office.

Meanwhile, the third utility model with registration number 2-2016000294 was granted to the research output of Engr. Enalyn T. Domingo, Engr. Ferdinand L. Marcos, and Engr. Don Louie A. Sanvictores from the College of Engineering, and is entitled \*Uninterruptible Power Supply with Switching Arrangement.

The application of the third utility model was facilitated under the leadership of Dr. Robert V. Marcos.

The faculty members responsible for the innovations were awarded certificates of recognition and cash incentives by TSU for their very significant contribution to the University.

Pursuant to its desire to uphold intellectual property rights, the Tarlac State University applied for the registration of the following marks with the Intellectual Property Office of the Philippines (IPOPHL):

TSU Official Seal (Application No.42016506151) The name "Tarlac State University" (Application No.420165061511

The acronym "TSU" (Application No.42016506152)

Through eTMfile, the online trademark application

system developed by IPOPhil, the TDTCO facilitated the application of the said marks on the last week of

The application aims to protect the trademarks of the University from unpermitted use or misuse.

The trademark application covers TSU's major services and products, from education and research services to

souvenir products like bags, mugs, and pens.

The usual processing period from application to final registration of a mark can take from about 3 months to a

year.
