WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Copier Consumables (APP 2023) with an Approved Budget for the Contract (ABC) of ₱ 3,424,500.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 17, 2023;

WHEREAS, in response to the Invitation to Bid, only one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on August 25, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on September 6, 2023, at 2:00 P.M.:

- (a) one bidder, namely, Philippine Duplicators, Inc., tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bid of the lone bidder and found it to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and was rated "passed",
- (c) the BAC resolved to declare Philippine Duplicators, Inc., as the bidder with the Single Calculated Bid with the amount of 2,659,521.20,
- (d) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the and Single Calculated Bid;

WHEREAS, in the Post-Qualification Evaluation Conference held TSU-BC AVR on October 12, 2023:


- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents,


- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive;


THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:


- (a) to declare Philippine Duplicators, Inc., as the bidder with the Single Calculated and Responsive Bid (SCRB), with the bid price of Two Million Six Hundred Fifty-Nine Thousand Five Hundred Twenty-One and 20/100 Pesos (₱ 2,659,521.20), and
- (b) to recommend to the President the Award of Contract for the project, Supply and Delivery of Copier Consumables (APP 2023) to Philippine Duplicators, Inc.





WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Copier Consumables (APP 2023) with an Approved Budget for the Contract (ABC) of ₱ 3,424,500.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 17, 2023;

WHEREAS, in response to the Invitation to Bid, only one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on August 25, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on September 6, 2023, at 2:00 P.M., one (1) bidder, namely, Philippine Duplicators, Inc. participated and tendered a bid for the aforementioned project,

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelope contained in the bid submitted by the lone bidder, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Philippine Duplicators, Inc. contained all the required documents and was rated "passed".

WHEREAS, the BAC with the assistance of the TWGs, then opened and checked the second envelope contained in the bid of the lone bidder and found that the second envelope contained the prescribed documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, then evaluated the financial bid of the lone bidder with the result as summarized below:
